Volvo infant seat base

Volvo infant seat base has been tested and certified in conjunction with the Volvo infant seat in accordance with GB 27887-2011.

"Semi-universal" with ISOFIX and support leg

WARNING

DO NOT use on passenger seats with front airbag!

 = Airbag off! Please observe the instructions on the use of child safety seats provided in your owner's manual.

Use in seating positions with ISOFIX

The Volvo infant seat in conjunction with the Volvo infant seat base is suitable for all vehicle seats certified as ISOFIX seats (as explained in the vehicle owner's manual), depending on the weight class of the child seat and the ISOFIX size class.

The weight class and the ISOFIX size class provided for this child restraint system is "D".

The following list of approved cars must be observed for this combination.

WARNING

Never support the support leg of the adapter against a storage compartment in the vehicle floor.



▼ = OK with storage compartment!
You must only use the adapter on the seats with storage compartment which have been checked and approved by us.

1. Please refer to the vehicle manufacturer for information on how to access the ISOFIX anchoring points at the vehicle seat.
2. The ISOFIX anchoring points deep in the seat cushion make installation more difficult. Please make sure that you properly engage both ISOFIX locking arms.
3. The middle row of seats must be as far forward as possible.
4. The vehicle seat must be as far back as possible. The support leg must not touch the storage compartment.
5. Only approved with additional filler in the storage compartment.



NOTE

Before you purchase the product, check that the vehicle is equipped with the appropriate anchorages.

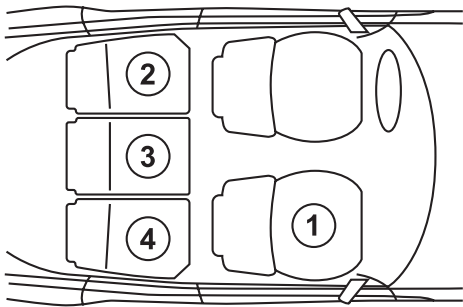
